Commissioner Campbell proactively contacted the Auditor's office for verification. The auditor's office verified it had received a letter and that FCMPD has no

employees and will be sending a letter with findings after it has looked into the allegations presented by the letter. Commissioner Watts stated that Friends of Fall City Parks covers the volunteer's expenses for river clean up. All FCMPD meetings are open to the public. The commissioners welcome community members to attend and learn about Fall City Metropolitan Park District and stay informed about the activities that FCMPD is engaged in.
