- 4.1 New Offsite Server
 - 4.1.1 Commissioner Harris reported that Bytegrid sold the company to Data Fortress. He wanted commissioners to be aware of the new off site server company.

- 5.1 River Recreation/Float Task Force Committee (Watts)
 - 5.1.1 Commissioner Watts reported on Fall City Float's activity. The cooler weather shortened season and cap placed on Fall City Floats by WDFW has helped to keep the number of floaters low.
 - 5.1.2 A previously approved funding application for additional information on floaters who do not use Fall City floats was not submitted by King County in time to be useful this year.
 - 5.1.3 Commissioner Watts attended a meeting regarding redrawing of the Raging River hazard migration zone. Checked on possible impacts on Bernard Park.
 - 5.1.4 Commissioner Watts attended a Statewide meeting of directors of WDFW. They visited PSE Park, Plum 1 and Plum 2. At the Plum sites, floating issues were discussed and WDFW's involvement in this type of recreation.
