# MONTHLY MEETING OF THE BOARD OF COMMISSIONERS OF FALL CITY METROPOLITAN PARK DISTRICT OF KING COUNTY, WASHINGTON HELD APRIL 9, 2013

The Regular Meeting of the Board of Commissioners of Fall City Metropolitan Park District (FCMPD) of King County, Washington, was held on April 9, 2013, at the Fall City Library located at 33415 SE 42<sup>nd</sup>, Fall City, Washington, at 7:00 p.m.

# 4 Public Comment

4.1 Del Moore suggested that the Park District evaluate the opportunity to submit an application for a King County CSA grants which are due May 31, 2013. He suggested that one idea worthy of consideration for the District was to add "Welcome to Fall City" signs at each of the four primary entry points to Fall City (SR 202 eastbound and westbound, SR 203 southbound, and the Preston-Fall City Road northbound). He suggested that these signs could also provide community information such as dates/locations of upcoming community meetings and town activities. Information for sign-sponsoring organizations could also be added to the sign. Coordination with WSDOT and King County would be required to install signs within their right-of-way.

#### **5** Committee Reports

- 5.1 Community Works River Recreation Committee (Wilkins)
  - 5.1.1 Del Moore reported that Brett Roberts of King County Parks has agreed to build a new river access trail from a point near the Hop Shed to the top of the dike. Volunteer effort will be needed to convey gravel left by King County crews on the land side of the dike to a new path on the river side of the dike. Commissioner Wilkins and Del Moore will organize the volunteer efforts once King County crews have completed their portion of the project.

# 5.2 Fall City Park (Moderow)

- 5.2.1 Commissioner Moderow reports that King County is still moving forward with four improvement projects to Fall City Park: new information kiosk near equestrian arena, improved trail access to equestrian arena, trail access improvements to the river (see 5.1.1), and new stairs over dike to near baseball field (see 5.2.2). Repairs of the perimeter fence will be fixed by KC Parks.
- 5.2.2 Commissioner Moderow reported that the Boy Scout project is still on track to be completed at Fall City Park this spring which is the new stairs over the dike near the baseball field (see 5.2.1).

# 5.3 Trail Connections

- 5.3.1 Commissioner Moderow met with Connie Blumen, King County Parks, at Connie's request regarding developing an update of the King County Equestrian Plan.
- 5.3.2 Commissioner Harris has been requested by Paula Reeves, WSDOT Local Programs, and has agreed to participate on panels at the upcoming Planning Law Conference in Bellevue and Revitalize Washington conference in Vancouver. Other panelists include Cynthia Welti, Director of the Mountains to Sound Greenway, and Dave Rodgers, principal engineer with SvR Design Company. The two sessions during these conferences will discuss issues and challenges associated with the trail development process. Ms. Reeves thought that Commissioner Harris would bring an important perspective of an unincorporated community park district working with WSDOT based upon their discussions about issues associated with developing a new non-motorized path in Fall City along SR 202 that is separated from the roadway.
