- **5** Committee Reports
 - 5.1 River Recreation Committee (Wilkins)
 - 5.1.1 King County Parks will build a trail from near the Hop Shed to the top of the levy at King County/Fall City Park. FCCA received a grant to cover most of the costs.

- It is unknown what entity will provide access from the top of the levy to the beach area.
- 5.1.2 The FCCA and King County may provide additional sani-cans at Quigley Park and King County Park.
- 5.1.3 The FCCA is working with King County to provide signage to temporarily direct traffic from downtown Fall City over the bridge to the King County Park during periods of peak river float activity.
- 5.1.4 Commissioner Moderow will work with the District's website developer to add a link to a river safety video created by King County.
