

FALL CITY RIVER FLOAT TASK FORCE
FALL CITY, WASHINGTON
February 15, 2011

A meeting between various local agencies and citizens within King County, Washington, was held February 15, 2011, at the Fall City Library located at 33415 SE 42nd PI SE, Fall City, Washington, at 7:00 p.m.

1. Call to Order

3. Discuss and Decide: Topics for this meeting

- A. River Task Force Video – This is a safety/educational video
- a. Find a spokesperson to narrate the video – Kaleb Williams (?)
 - i. Find someone from age 18-25 so viewers can relate
 - b. The Snoqualmie River is a dangerous, constantly changing river system. Serious hazards must be navigated. Proper equipment and personal safety gear is required for everyone. Enter at your own risk.
 - c. The Snoqualmie River is closed at the base of the Falls. The first available access point is Plum #1 at the South end of 372nd off Highway 202. There are parking restrictions in this area. Recreational parking permits required for most parking in this area. Permits can be purchased anywhere fishing licenses are sold. Cash only “Pay to Park” private lots may be available on select weekends, at property owner’s discretion. Improperly parked cars will be towed at owner’s expense.
 - d. Santi-cans and garbage receptacles are located at the Plum #1 access point. Other restroom facilities and garbage disposal is available in Fall City at most exit points. Please contain your trash and dispose of it properly in the designated areas. Do not sink your empties. Do not throw trash in bushes. Litter fines will be enforced.
 - e. This river is part of the unincorporated King County; there are no personnel or funds for removing trash from this natural area. You are asked to respect this area, to preserve its natural beauty, and protect the habitat for the wildlife. Remove your trash. Leave no trace. Please be safe.
 - f. Need a visual map from King County for ease of downloading.
 - g. Parking – where to park legally

- i. Permit required areas
 - ii. Possible pay parking areas
 - h. Trash – Reminder to respect, where to dispose of trash properly
 - i. Unincorporated King County, and what that means
 - ii. Show river litter fine sign
 - 1. Show litter collected previously
 - 2. Reminder/don't sink garbage
 - i. Safety – Lifevests are advised for everyone – People drown here
 - i. Loaners – location for use and return
 - ii. Hazards exist, use proper equipment
 - 1. Paddles are needed
 - 2. Obstacles
 - 3. Where to exit river/return to parking at King County park
- B. PRKC Partnership for Rural King County
 - a. Submitted a Letter of Intent from the Russell Family for a \$10,000 Grant
- C. Establish Route
 - a. Water/Boats
 - b. People
 - c. Cars/Parking
 - d. Mark it “Patron Parking Only” on the business side of the road
- D. Locations/Services
 - a. Santi-Cans
 - b. Garbage
 - i. Need to obtain golf course approval to place trash/recycle receptacles (Perry Wilkins will consult with the Groshell's)
 - c. Recycle
- E. River Safety
 - a. Lifevests
 - b. Patrols/Sheriff
- F. Horse and Buggy Shuttle Service
 - a. It's “green” and all natural
- G. Consult the Boy Scouts
 - a. Strong “leave no trace” philosophy
- H. Supply 5 locations for trash disposal
 - i. Plum #1 – Crib only, no dumpster
 - ii. Plum #2 – Crib
 - iii. Mid-river (potential golf course location) – Crib on a sled
 - iv. Campground boat launch (easement to King County) - Crib
 - v. Exit point West of the bridge (in town) - Dumpster
 - vi. Exit point Northwest of the bridge at the King County parking lot across the river – Dumpster
- I. King County has agreed to pay for additional/larger dumpsters in various areas
 - a. King County DOT has small bags they can supply for free.
- J. Santi-Cans
 - a. Put (4) four at the Fall City Park at the new take-out area
 - b. Plum #1
 - c. Plum #2
 - d. Campground boat launch (easement to King County)
